Product

This document relates to the 'ESG Individual Savings Account' provided by Red Rose Assurance (the Society), which is the trading name of the Red Rose Friendly Society Ltd. The Society is authorised by the Prudential Regulation Authority (PRA) and regulated by both the PRA and the Financial Conduct Authority (FCA). This document was produced on 4 January 2021. **This document shows the values for regular investments of £1,000 per year and with no withdrawals being taken (the example plan).**


What is this product?

ESG ISA

Type	The product is an Individual Savings Account (ISA). It is a tax-efficient way in which you can save without having to pay income or capital gains tax. The ISA is a Stocks and Shares ISA.
Objectives	<p>To increase the value of the money you invest with us and to provide an accessible tax efficient investment from which you can take withdrawals.</p> <p>The minimum single lump sum you can invest is £500. The minimum regular investment you can make is £25 per month. There is a maximum amount you can invest in an ISA which may change each tax year. The total ISA allowance for the 2020/21 tax year is £20,000 which includes investments in both a Stocks and Shares ISA and a Cash ISA.</p> <p>The plan is available for UK residents aged 18 or over.</p> <p>We will invest any monies received in our ESG Investment Fund. The fund is currently managed by a specialist team at Legal and General. It invests in global developed-market equities, mainly large companies in a variety of countries and sectors, including Communications and Technology, Consumer, Industrials, Financial Services and Commodities. It aims to track the performance of the Solactive L&G Enhanced ESG Developed Index.</p> <p>It does not invest in 'pure' coal miners, manufacturers of controversial weapons or perennial offenders of the UN Global Compact (a global platform for business and non-business entities to proactively network and engage in areas of human rights, labour, environment, and anti-corruption).</p> <p>The value of the Fund (and therefore your own holdings) may go down as well as up as the underlying assets fluctuate in value. The return on your investment is dependent on the performance of the fund.</p>
Intended retail investor	Individuals with an investment horizon of at least 5 years and a medium appetite for risk.
Insurance benefits and costs	Upon your death, 101% of the value of your ISA will be paid. Please note that this could be less than the amount invested, depending upon the investment performance of the Fund

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator (SRI) assumes you keep the product for 10 years.

The SRI is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product may lose money because of future investment performance or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor financial market conditions could impact the capacity of Red Rose Assurance to pay you. This product will pay the value at the date of withdrawal. If Red Rose Assurance is not able to pay you what is owed, you could lose your entire investment. However, you may have recourse through the Financial Services Compensation Scheme.

Performance Scenarios

The following table shows the money you could get back over the next 10 years, under different scenarios, assuming that you invest £1,000 per annum and no withdrawals are taken. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies and are not an exact indicator. What are the costs?

Costs over time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown below are the cumulative costs of the product itself, for the example plan, for three different holding periods. The figures assume £1,000 per year is invested and that no withdrawals are taken. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

The product is a medium to long-term contract. Full and partial withdrawal or transfer to another ISA provider is allowed at any time but you may get back less than you have invested.

Based on the above information the recommended holding period for the product is at least five years. For the example plan the recommended holding period is 10 years.
